Re: Petition about Sunbus Services to the Northern Suburbs of Cairns

Thank you for your petition lodged by Dr Lesley Clark MP, Member for Barron River in Parliament on 28 April 2004 about Sunbus services to the northern suburbs of Cairns. As this matter is managed by Queensland Transport (QT) and within my portfolio, I take this opportunity to advise you on what has transpired since your petition was tabled.

I am advised that QT and Marlin Coast Sunbus have been working together to resolve a range of vehicle safety and scheduling issues. A working group consisting of Departmental officers and Sunbus representatives was established on 23 March 2004 to develop an action and implementation plan. The plan will address issues identified in a recent audit conducted by QT. It will also allow Departmental officers to monitor Sunbus operations and ensure that the requirements of the relevant legislation are met.

One of the Government's election commitments was to improve passenger transport across the State and QT is currently working on changes to the network. As part of these changes for the Cairns area, an earlier connection between Yorkeys Knob / Holloways Beach and Smithfield / University will be provided.

On Sundays, most trips will be extended to Smithfield and James Cook University, operating similarly to the other days of the week. Route services through Redlynch would be extended to Smithfield on Sundays. These changes are subject to a 12 month review.
